

## Kicks 99 Mega Ticket Stop Contest

### OFFICIAL CONTEST RULES

These rules apply to the Kicks 99 Mega Ticket Stop Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a WKXC (“Station”). **In addition, the General Contest Rules posted at [www.kicks99.com](http://www.kicks99.com) apply to this Contest. #### 1) HOW TO ENTER

## 2) ELIGIBILITY RESTRICTIONS

- This Contest is open to all Station listeners who are 18 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in Columbia, Richmond, Burke, McDuffie, Glascock, Hancock, Jefferson, Jenkins, Taliaferro, Warren, Washington, Wilkes, and Lincoln Counties, GA and Aiken, Allendale, Barnwell, McCormick, and Edgefield Counties, SC, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility
